Jason Brendel stated that the revolving door near the Greyhound station needs repaired.

Jason Brendel reported that not all EMTA drivers are in uniform. There was discussion regarding the importance of maintaining a professional appearance while dealing with the public.

Jason Brendel pointed out that the current practice of switching drivers is an inconvenience to the passengers.

Carol Hirsch and Stefanie Russell brought up the issue with the early morning/late night bus routes. If a Hamot employee has a 7am start time they cannot use the bus to get to work in the morning and if their shift ends at 11pm they cannot use the bus to get home. Chris Gerhart suggested possibly conducting a survey to see where the early/late routes are needed.

Carol Hirsch and Stefanie Russell explained Project Search.

Kim Brown explained that if a LIFT driver arrives earlier than a customer's pick up window that the customer is not obligated to board the bus early. The LIFT driver either has to wait until the beginning of the pick up window or come back for the customer within the scheduled time.

Andrew Kappes asked why there are no bus routes that travel from one side of town to the other. He pointed out that all routes require a customer to transfer if they need to travel across town.

Andrew Kappes stated that he would like to see customers be able to transfer at no cost.
