CALL TO ORDER:

PUBLIC COMMENTS:

Freda Trepfer: Checked 29th Schedule – the map online was not where the bus was traveling. Made call to customer service and took awhile to get person to take her seriously. Online map was updated/corrected. Bus 29 runs on 1-hour intervals. Bring public in on planning process. Concerned that the planning process is so long before public is brought in.

Sheila Woeger: Am frequent rider of bus and lift. A passenger needed to go to ER – the driver had to charge her \$20. Feels it is not fair. Asked for ride to city council meeting. Was charged \$20 for a one-way ride to meeting to council meeting. City of Erie is behind in how it schedules rides. Something needs to be done to assist seniors. – On bus and their appeared to be a young student that showed driver a bus pass, but driver refused to take it. Driver said he was new – but the young man had to exit the bus and was disappointed. It appeared that the student would miss school.

Mary Lee: Question: Frequent rider. What will be done to put ramp down for someone that has a spinal injury? Issue has not been addressed. Afraid she is going to fall again. Make it more affordable to get on the bus since driver won't put the ramp down. Am agitated about safety concern. (Jeremy: this will be discussed and EMTA will get back to her). Bus 32.

Passle Helminski: Reorganizing E&D committee. Getting people together in the next week or so.
