Safety Review Round Table – Received more awards than any other PA agency.

6 new CNG buses to arrive by January.

Mercer Transit meeting with CATA – Jeremy discussed Fritz project, Ecolane, and transit funding.

Christian Silvera explains EMTA was paying 11.6 kilowatts per hour. Two product options are either fixed or a utility supply. New World introduced a Managed Product option to avoid locking in long-term prices. Managed product delivers a significantly lower price.
